Deadline for Submission of Revised 2019 Statement of Assets, Liabilities and

Net Worth (SALN)

- This is to inform that all teaching and non-teaching personnel of the DepEd Tabuk City
  Division are mandated to submit their 2019 SALN. All employees are required to declare
  true and complete declaration of assets, liabilities, net worth, business interests and
  financial connections including those of the spouse and unmarried children below 18 years
  of age living in their parent's household.
- The sanction for non-compliance shall constitute a violation of the law (R.A 6713) and punishable by suspension of one month to six months for the first offense and dismissal from the service for the second offense. SALN is also a requirement for the grant of Performance Based Bonus (PBB).
- The approving authority should be the Schools Division Superintendent or notarized by a lawyer.
- 4. Relative to this, for elementary and secondary, SALN should be submitted to the office of the Administrative Officer V through the Records unit by their respective Public Schools District Supervisors, while for the Division Office Personnel by their respective unit/section chief/head.
- Submission of the required revised SALN 2019 as of December 31, 2019 will be on or before February 21, 2020 with hard and electronic copy saved in flask drive. Must be saved individually in PDF format.
- 6. Attached herewith is a sample copy of the Revised SALN form 2019.
- 7. Unit heads & school heads may secure a soft copy of the form including the guidelines at the office of the Administrative Officer V.
- 8. For information, guidance and strict compliance of all concerned.
