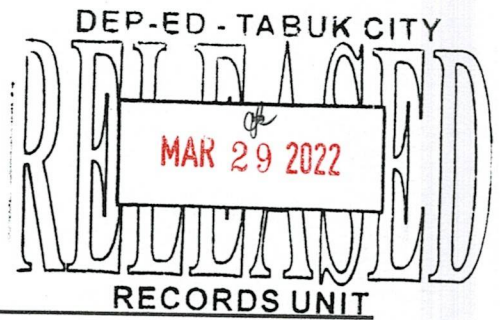

DIVISION MEMORANDUM

No. 103 s. 2022

SIGNATORIES FOR SCHOOL PARTNERSHIP AGREEMENT

TO: All Elementary and Secondary School Heads
All School Partnership Focal Person
All Others Concerned

1. The partnership agreements entered into by the schools shall be signed by the Head of the School concerned and thereafter ratified by the Division Schools Superintendent.
2. It shall be applicable to all partnership agreements such as Memorandum of Agreement (MOA), Memorandum of Understanding (MOU), and other similar documents entered into between DepEd Tabuk and its public elementary and secondary schools effective March 18, 2022.
3. Any partnership building activities initiated by the school shall be governed and be guided by the following policies and principles:
 - a. DepEd shall enter into partnerships in order to strengthen its capability to offer basic education.
 - b. Partnerships will be entered into only after thorough study and preparation to ensure that these will be beneficial to the students and learners, teachers and schools
 - c. Partnerships should be aligned to the School Improvement Plan and Annual Implementation Plan (SIP/AIP) and discussed with stakeholders in a documented meeting in accordance with School-Based Management (SBM) standards.
 - d. All partnerships at the school level must be covered by a Memorandum of Agreement (MOA), all partnerships shall be guided by relevant existing laws and DepEd issuances especially those related to child protection.
