**LIMITED FACE-TO-FACE CONSULTATION AND CONDUCT OF TECHNICAL ASSISTANCE in RESEARCH**

1. RA 9155 also known as the Governance of Basic Education Act of 2001 and RA 10533 otherwise known as the Enhanced Basic Education Act of 2013 mandates DepEd to engage in research activities so that the policies crafted, and the curriculum shall be relevant, responsive and research-based.

2. In addition, one of the requisites of the K-12 Program is accelerating research and development. However, in the previous years, proposals have been submitted but there was no forum between the proponents/researchers and the evaluators especially during the pandemic except for when the SEPS would personally approach if not call the researcher for clarification and vice versa.
