- 1. This is to inform you that an activity entitled "Long-Term School Strategic Plan 2022-2028: 2nd Loop of Re-Engaging Schools on the Next Cycle of School Improvement Plan" will be conducted on October 6, 2022 via an online platform.
- 2. This is a follow-through of the SIP orientations that we had last November to December 2021 as there are important updates needing consideration in the next SIPs of schools, such as clarifications and alignment of SIP programs, projects, and activities with the new pillars (Access, Equity, Quality, Resiliency and well-being, and Governance), strategies, and outputs along with the integration of learning continuity and recovery mechanisms, and new targets set across governance levels. This is aside from updates as to the structure of SIP after a review of the Planning Service, which is now the process owner in the implementation of the SIP and SRC as articulated under Memorandum DM-HROD-2022-0034 dated January 5, 2022.
- 3. In this connection, therefore, all school heads are required to attend this virtual activity with their respective teachers and PTA representatives. School heads are advised to ensure that internet connectivity or enough internet data is available for them and their participants and that they are assembled in one area for the remote workshop session. In this case, the school heads are expected to facilitate the workshop in their respective remote locations.
