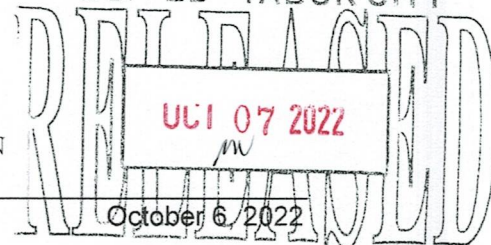

CONDUCT OF TECHNICAL ASSISTANCE in RESEARCH

1. Accelerating research and development geared toward continuous improvement, particularly in the delivery of quality education to learners, is one of the requirements of the K-12 Program. In previous years, proposals were submitted, but there was never a forum for discussion between the proponents/researchers and the evaluators, particularly during the pandemic, except for times when the SEPS would personally approach, if not call, the researcher for clarification and vice versa. Since there is no communication between the researchers and the review committee, proposals that are returned are not resubmitted or revised, which halts the research cycle.

3. The attendance of the identified personnel during the abovementioned activity is desired. They are also expected to observe the minimum health and safety protocols during the activity. The participants shall be entitled Compensatory Overtime Credits for the non-teaching personnel and Service Credits for the teachers pursuant to DepEd Order No. 53, s. 2003 and CSC DBM Joint Circular No. 2 s. 2004 on the "Non-monetary Remuneration for Overtime Services Rendered," which provides that teachers who attended seminars, trainings and other required activities during Saturdays, Sundays and holidays are entitled to service credits equivalent to the number of days they attended and employees who render overtime work beyond the required forty (40) hours of work in a week shall be entitled to compensatory time off equivalent to 1.5 x the number of hours rendered on weekends, holidays or scheduled days off, respectively.
