Support to the Department of Health Bakunahang Bayan on December 5-7, 2022

1. Pursuant to DepEd Order No. 51, s2022 entitled “ An Order to Support the Department of Health Bakunakang Bayan from December 5 to 7, 2022” SDO Tabuk City strongly support the aforementioned activity to further protect its high risk personnel from COVID 19 death with booster vaccination and provide opportunities for learners to make informed decisions on COVID 19 and vaccination.
2. The COVID 19 vaccination is not mandatory and remain to be voluntary for all personnel and learners. All minors who volunteer to be vaccinated should have the consent of their parent or legal guardian. All minors who want to be vaccinated but cannot secure the consent of parents or legal guardians should seek the assistance of social workers from the Department of Social Welfare and Development.
3. To effectively implement the Bakunahang bayan consistent with the Dep Ed policy of strict adherence to the school calendar and recovery from the learning losses, and the unloading of non-teaching work of teachers, the following should be observed:
 - 3.1 All Dep Ed teaching and non-teaching personnel, including job order personnel, contract of service personnel, and learners who volunteer to be vaccinated during the period of Bakunahang Bayan on December 5-7, 2022 shall automatically be excused from absence on the day of the vaccination provided that they should present to their respective head/s of office a copy of the COVID 19 vaccination record card or any proof of vaccination.
 - 3.2 All learners who volunteer to be vaccinated during the period of Bakunahang Bayan on December 5-7, 2022 shall automatically be excused from attending their classes on the day of the vaccination provided that they should present to their respective class adviser or school teacher a copy of the COVID 19 vaccination record card or any proof of vaccination.
 - 3.3 The School Health Unit shall coordinate with their counterparts from the DOH conduct information sessions to provide relevant information on COVID 19 vaccines and the process of vaccination. Sessions can be integrated in Science and Health classes. NO CANCELLATION or SUSPENSION of classes are allowed during their sessions.
