CONDUCT OF ONE HEALTH WEEK FOR SY 2022-2023

- Pursuant to DepEd OUGGFO Memo 2022-03-1037 entitled "Guidance to Regional /Division School Health and Nutrition Personnel re: Conduct of the One Health Week for SY 2022-2023, all public elementary and secondary schools are directed to conduct their respective One Health Week on January 30 to February 3, 2023.
- 2. The theme for the celebration is "Pinalakas na Kalusugan sa Dep Ed, Pinatatag na Healthy Learning Institutions" emphasizing the implementation of Oplan Kalusugan sa DepEd six(6) flagship programs namely:
 - a. School Based Feeding Program (SBFP)
 - b. School Mental Health
 - c. Adolescent Reproductive Health (ARH)
 - d. Medical/Dental/Nursing Services
 - e. Water, Sanitations and Hygiene (WASH/WinS)
 - f. National Drug Education Program (NDEP)
- 3. The activity aims to ensure that schools as Healthy Learning Institutions (HLI) promote the health, safety and well-being of learners and personnel by providing basic medical and dental services which allow them to attain their full potential towards healthier behavior and better learning outcomes.
- The schools that have previously conducted similar activities for SY 2022-2023 shall no longer conduct the said activities on January 30-February 3, 2023.
- 5. The One Health Week shall be monitored by the assigned School Health Personnel and shall provide necessary technical assistance to the schools.
