#### ANNUAL MEDICAL EXAMINATION OF DEP ED PERSONNEL CY 2023

- 1. Pursuant to the Dep Ed Memorandum No. 22s 2015 entitled "Annual Physical Examination of DepEd Employees (Teaching and Non-Teaching personnel) as per RA 1123 "The Universal Health Care Act, its Implementing Rules and Regulations, and in compliance with the Civil Service Commision Memorandum Circular No. 17 s 1989, all SDO Tabuk City employees (Teaching and non-teaching personnel) are required to undergo Annual Physical examination.
- 2. The physical examination aims to ensure that all teaching and non-teaching personnel are physically fit to perform their assigned tasks and functions.
- 3. The following radiologic examination and laboratories are strongly recommended by the medical officer.

Chest X-Ray PA (At least 6months validity if personnel has already undergone chest X-Ray) Except for Pregnant personnel

#### a. For 35 years old and below:

Chest X-Ray CBC Urinalysis

#### b. For 36-39 years old

Chest X-Ray **CBC** Urinalysis Fasting blood sugar Lipid Profilehas Blood Urea Nitrogen

Creatinine Blood Uric Acid

Pap Smear for women (Optional)

4. Teachers' Annual health Examination and Form 86 certification may be conducted by any of the following:

A. Any government based physician.

- B. The SDO Medical Officer per appointment at the SDO clinic or by District scheduling in the SDHCP Central clinics.
- C. Any private medical practitioner on personnel's preference. The annual medical and physical examination expense of teaching personnel is covered by cash allowance granted under Dep Ed Order No. 13 s 2021 entitled "Supplemental Guidelines on the Grant of Cash Allowance to Teachers".
- 5. School nurses shall collect all Form 86 of teaching and non-teaching personnel with attached photocopy of laboratory and diagnostic results on or before May 15, 2023.
- 6. School nurses are required to submit consolidated Form 86 on or before May 31, 2023.
- 7. Dental/oral examination shall also be conducted by the Division Dentists.

- 9. Immediate dissemination and compliance of this memorandum is required.
