Philippine Identification System (PhilSys) School Registration Campaign of the Philippine Statistics Authority (PSA)

- 1. This has reference Advisory No. 020-2023 dated February 23, 2023, issued by the DepEd CAR Regional Director responding to the PSA's request for assistance in their conduct of School Registration Campaign. The PSA is mandated as the primary agency in implementing RA 11055, otherwise known as the Philippine Identification System. The PhilSys is established to give valid proof of identity to all citizens. Additionally, it intends to increase financial inclusion, prevent fraud and misrepresentation, and advance corporate efficiency.
- 2. In this connection to this, in response to a letter dated March 2, 2023, from the Provincial Statistics Officer (PSO) of PSA Kalinga, all schools in SDO Tabuk City are enjoined to participate in the PhilSys school registration campaign until such time that all schools in the city have been covered. 
