> CONDUCT OF THE ENGLISH, SCIENCE, AND MATHEMATICS ASSESSMENT FOR THE NATIONAL LEARNING CAMP FOR GRADE 7 AND 8 FOR THE SCHOOL YEAR 2022- 2023

TO: Public Schools District Supervisors
Public and Private Secondary School Heads
All Others Concerned

- Pursuant to DM-OUCT-2023-148, the Schools Division of Tabuk City shall administer the National Learning Camp Assessment for English, Science and Mathematics. This is an online computer-based test for all enrolled Grades 7 and 8 public school learners that will be delivered through the DepEd LMS platform. The test shall cover learning areas in English, Science, and mathematics, wherein test items measure varying levels of skills and competencies in a multiple-choice format using the English language.
- 2. The assessment tool intends to determine the effectiveness of the learning camp intervention on the learning competencies of participating learners before and after attending the said program.
- 3. The NLCA will be simultaneously conducted in 5 testing centers that are able to hold the necessary requirements, with computer laboratory or available computer units and with stable internet connections. These are the following schools:
