(POST TEST) FOR INCOMING GRADE 8 AND GRADE 9 LEARNERS  
FOR SY 2023-2024**

1. In reference Memorandum DM-OUCT-2023-230 re: The National Learning Camp Assessment (NLCA) is an online computer-based assessment that is designed to evaluate the learning achievements of learners who participated in the national learning camp program. The pre-test for the NLCA was administered before the start of the camp to all enrolled Grades 7 and 8 learners of the School Year (SY)2022-2023 last July 2, 2023 to July 7, 2023.
2. At the end of the camp, the Bureau of Education Assessment (BEA) shall administer **the NLCA post-test to all incoming Grades 8 and 9 learners of SY 2023-2024 from September 6 to September 16, 2023**
3. The Post Test shall cover **English, Mathematics and Science**, wherein test items measures varying levels of skills and competencies in a multiple-choice format using the English language.
4. All Grade 8 and 9 who took the NLCA Pre-test are requested to check and update their DepEd Email addresses with the assistance of their School Information Technology Coordinators before the test administration to ensure that the learners have correct log-in credentials in their Learning Management System (LMS) Moodle platform.
5. Prompt and immediate dissemination of this Memorandum is earnestly desired.
