- c. Complete and duly accomplished Personal Data Sheet (CS Form No. 212, Revised 2017) with Work Experience Sheet,
- d. Valid and updated PRC License
- e. Transcript of Records or Diploma of earned Bachelor's Degree, and if available Means of Verification for earned post-graduate units or degrees,
- f. Certificates of Specialized Trainings, if any
- g. Duly signed Service Records,
- h. Duly signed Performance Rating and school clearance for those with teaching experience. If unavailable, the applicant must submit a justification citing the reason/s for unavailability.

In cases where applicants do not have the appropriate educational qualifications for SPED, they may still be evaluated but shall be categorized separately from those who have met the said requirements.

- b. He/She must have at least three (3) years of experience in providing educational services to any of the categories of children with special needs. This is to be verified by a certification from the Principal to be submitted as part of the application.
- A certification from the Principal that the applicant has had a Very Satisfactory Performance Rating for the last three (3) years must be submitted as part of the application.

Additional requirements for SPED Secondary Applicants

He/She must possess any of the following qualifications:

- Bachelor of Secondary Education, major in Special Education
- Bachelor of Secondary Education plus 18 units in Special Education in the Graduate Level
- Bachelor of Secondary Education plus 15 units in Special Education with two (2) years of very satisfactory teaching experience in the regular schools and is willing to be trained within a year
- Bachelor of Secondary Education plus 12 units in Special Education with four (4) years of very satisfactory teaching experience in the regular schools and is willing to be trained within a year
- Bachelor of Secondary Education plus 9 units in Special Education with six (6) years of very satisfactory teaching experience in the regular schools and is willing to be trained within a year
- Bachelor of Secondary Education plus 2 years of very satisfactory teaching experience as a SPED teacher
- Individuals who failed to submit the complete and fully accomplished mandatory requirements on the set deadline indicated in this memorandum shall not be included in the pool of official applicants. No additional documents shall be accepted after the set deadline.
