DIVISION CLINIQUING FOR REGIONAL SCHOOLS PRESS CONFERENCE (RSPC) QUALIFIERS AND COACHES

To: Public Schools District Supervisor School Heads of Public/ Private Elem/Secondary Schools All Coaches of the 2024 RSPC Qualifiers

- As part of the Division's preparation for the 2024 Regional Schools Press Conference (RSPC), the Curriculum Implementation Division (CID) shall conduct the Division Cliniquing For Regional Schools Press Conference (RSPC) Qualifiers and Coaches on April 20, 2024 Saturday at the Bulanao Central School, Bulanao Tabuk City.
- 2. The activity aims to:
 - a. Enhance the journalistic competence of the RSPC qualifiers cum improve the journalistic skills of the SPAs and teacher- coaches.
 - b. Be informed of Regional Memorandum No. 180 s., 2024 on the Conduct of the 2024 Regional Schools Press Conference (RSPC)
 - Be oriented with their roles and responsibilities as RSPC contestants and coaches.
- 3. Participants are the **Top 3** winning coaches and qualifiers in the Individual Writing Contests English and Filipino in the elementary and Secondary levels; **Top 1** winning coaches and qualifiers in the Group contest English and Filipino elementary and Secondary, Technical Working Group (TWG) and SPA Officers. However; with reference to **Regional Memorandum 180 s., 2024 Conduct of Regional Schools Press Conference,** the Top1 Individual and Group Contests shall be accompanied by their coach and the top 2 and 3 in the individual contest shall be accompanied by the school head or head teacher. (Encl 1 contains the list of pax for the cliniquing)
- 4. A registration fee in the amount of Two Hundred Pesos (PhP 200) shall be collected from each participant to cover honorarium of invited Resource Speakers and other needs charged against school local funds/journalism funds/ canteen funds or any available funds subject to the usual accounting and auditing policies/rules and regulations. Meals and travel expenses of participants shall be provided by the school / PTA.
