- 4. The school heads participating in this activity are enjoined to assign an Officer-in-Charge while the five teacher participants are expected to prepare a learning plan with the learning resources to be utilized by their learners during their absence. The template for the learning plan is attached as Enclosure A of this memorandum.
- 5. The expenses for the meals and snacks and accommodation of all the participants will be charged against the 2024 IPED PSF of the Regional Office while their transportation expenses will be charged against local funds subject to existing government auditing and accounting rules and regulations.
