### ADMINISTRATION OF THE 2024 ACCREDITATION AND EQUIVALENCY TEST FOR SCHOOL YEAR 2024-2025

**Public Schools District Supervisors** Public Elementary and Secondary School Heads **Community Learning Centers** All Others Concerned

- 1. The Department of Education (DepEd), through the Bureau of Education Assessment (BEA) in coordination with the Bureau of Alternative Education (BAE), this division shall administer the 2024 Accreditation and Equivalency (A&E) Test.
- 2. Pursuant to Memorandum DepEd Order No.55, s. 2016 titled 2024 Accreditation and Equivalency Examination (Policy Guidelines on the National Assessment of Student Learning for the K- to 12 Basic Education Program), The A&E Test aims to measure the competencies and life skills of those who have not attended or finished formal elementary or secondary education. This assessment shall allow the learners to obtain certification of completion at different exits in Basic Education, which may be used to access further education, job promotion, entry to job training, and employment.
- 3. The A&E shall be administered on January 26, 2025 which shall be held in 2 Testing Centers and with eight testing rooms . The Personnel involve in the test are the following:
