
- 2. The function of the National and Local Election Task Force members includes, but are not limited to the following:

- c. Serve as DepEd institutional link to volunteer organizations and individuals.
- d. Provide close horizontal and vertical coordination and consultation among DepEd, COMELEC, and partner agencies involved in the 2025 National and Local Election.
- e. Complement the other government agencies' effort for an honest, orderly, and peaceful elections.
- 3. The National and Local Election Task Force shall ensure that teachers are provided with adequate information, technical and legal assistance during the performance of their duties as members of the Election Borad, as well as DepEd Non- Teaching personnel who will serve in the May 12, 2025 National and Local Election.
- 4. The SDO- Tabuk City Election Task Force Operation and Monitoring Center shall also serve as DepEd institutional links to volunteer organizations, individuals, and partner agencies involved in the conduct on the 2025 National and Local Elections.
- 5. To facilitate monitoring the districts are clustered. All issues and concerns shall be directed to the identified focal person.

- 7. All ETF members shall be entitled to honoraria, subject to the availability of funds and in compliance with applicable issuances of the Commission on Audit and the Department of Budget and Management.
 - a. ETF members holding *Plantilla* positions shall have the option to receive either honoraria or claim overtime pay or compensatory time off (CTO). Likewise, Contract of Service personnel assigned to the ETF may opt to receive either honoraria or overtime pay.
 - b. An ETF member who opts to receive honoraria shall no longer be entitled to claim overtime pay or CTO.
 - c. The grant of honoraria, overtime pay, or CTO shall be subject to the approval of the ETF Chairperson at the respective governance level and shall comply with existing budgetary, accounting, procurement, and auditing rules and regulations.
- 8. Furthermore, all DepEd Tabuk City employees and officials are reminded not to intervene directly or indirectly in any election campaign or engage in any political activity.
- 9. Immediate dissemination of this Memorandum is direct.
