

- 1. The Schools Division of Tabuk City pursuant to DepEd Order No. 19, s. 2022 or the DepEd Merit Selection Plan upholds the principles of merit, fitness, competence, equal opportunity, transparency, and accountability in the Recruitment and Selection of personnel to ensure the placement of the right people for the right job at the right time.
- 2. Relevant to this, the Human Resource Merit Promotion and Selection Board (HRMPSB) announces the submission of intent of all aspiring Teacher-In-Charge in the Schools Division of Tabuk City. Incumbent TICs are required to submit their documents and will also be assessed. Application is open to all interested and qualified applicants, including persons with disability (PWD), members of the indigenous communities, and those from any sexual orientation and gender identities (SOGI). All applicants must register and obtain their application code through this link: tinyurl.com/sdotccodeapp-2. Failure to register through the designated link and secure an application code shall result in exclusion from the pool of qualified applicants.

3. Basic Qualifications of aspiring TICs are as follows:

Criteria	Qualification Standards
Education	Master's degree in education, or educational management, or Educational Leadership; or Master's degree in relevant learning area with at least 9 units in Management
Training	32 hours of training in any of or a cumulative of the following: Curriculum, Pedagogy, School management and Operations, Instructional Leadership acquired within the last 5 years
Experience	5 years teaching experience and 1 year relevant experience in any of the following: learning area coordination, subject area supervision, school management and operations, instructional supervision
Eligibility	RA 1080 (Teacher)


