- 1. All concerned are hereby informed of the conduct of the 2nd Quarter Division Monitoring & Evaluation, and Plan Adjustment (DMEA) on **July 7, 2025**, as per Division Memorandum No. 197, s. 2025 entitled "Schedules for the Conduct of Division Monitoring & Evaluation, and Adjustment Conference". The venue shall be announced later.
- 2. Major PPAs to monitor are those indicated in the Program Expenditure Classification (PREXC) and are usually captured in the Budget Execution Document No. 2 (BED 2) of DepEd. The major PPAs include but not limited to:
  - a) Human Resource Development for Personnel in Schools and Learning Centers or training of teaching, teaching-related, and non-teaching personnel;
  - b) Flexible Learning Options like ADM;
  - c) Inclusive Education Program SNED, IPED, MEP, ALS;
  - d) Trainers Training Methodody:
  - e) National Learning Camp or related program;
  - f) Operations of Library Hubs Newcon/Repair;
  - g) Policy and Research Program;
  - h) Disaster Preparedness and Response Program;
  - i) Learner Support Program OKD-SBFP, WinS, Career Guidance, Learner Right and Protection Program; and
  - j) Other programs.
- 3. The functional divisions in the division office shall conduct their respective Program Implementation Review (PIR-cum-MEA) earlier than the above schedule and ensure a complete report for presentation during the DMEA.
