

### SUBMISSION OF DOCUMENTS OF ASPIRING TEACHER-IN-CHARGE TIC)

- 1. The Schools Division of Tabuk City pursuant to DepEd Order No. 19, s. 2022 or the DepEd Merit Selection Plan upholds the principles of merit, fitness, competence, equal opportunity, transparency, and accountability in the Recruitment and Selection of personnel to ensure the placement of the right people for the right job at the right time.
- 2. In line with this, the Human Resource Merit Promotion and Selection Board (HRMPSB) of the Schools Division of Tabuk City announces that all aspiring Teacher-In-Charge applicants, including current TICs, must submit their letters of intent to the Records Section on or before 3:00 p.m. of July 7, 2025, for evaluation and assessment.
- 3. Application is open to all interested individuals, including persons with disability (PWD), members of the indigenous communities, and those from any sexual orientation and gender identities (SOGI) provided they shall meet the following Minimum Qualification Standards:

Training	32 hours of training in any of or a cumulative of the following:
	Curriculum, Pedagogy, School management and Operations,
	Instructional Leadership acquired within the last 5 years
Experience	5 years teaching experience and 1 year relevant experience in any of the following: learning area coordination, subject area supervision, school management and operations, instructional supervision
Eligibility	RA 1080 (Teacher)

- 5. All aspiring TICs are hereby instructed to submit four (4) sets of their documents, properly labeled and tabbed, enclosed in a LONG **RED** FOLDER (See Annex 1). Each set of folders must include the following:

- 7. Duly signed Service Records or Certificate of Employment,
- 8. Copy of the latest/current Performance Rating of at least one (1) year with at least a Very Satisfactory Rating,

  - a. Certificate of Recognition for Awards and Recognition,
  - b. Research and Innovation,
  - c. Subject Matter Expert/Membership in a National Technical Working Groups (TWGs) or Committees,

- For uniformity and to ensure a seamless and efficient conduct of the comparative assessment, applicants are advised to be guided by the following criteria for assessment and its Means of Verification:

Criteria for Assessment	Documentary Requirement/Means of Verification
Education	Copy of the Official Transcript of Records (TOR); Certification of units earned in the Masters or Doctorate Degree specifying the major of the course (Certification of Grades will not be accepted)
Training	Certificate of Participation/Attendance/Completion for the last five (5) years to relevant trainings and capacity building programs such as: Curriculum, Pedagogy, School management and Operations, and Instructional Leadership acquired within the last 5 years
Experience	Duly signed Service Records and Designation as learning area/ subject area coordinator with duly approved action plan and accomplishment report, and/or Official Designation as TIC as proof of experience in school management and operations, and instructional supervision
Outstanding Accomplishment	Awards and Recognition. Certificate of Outstanding Employee Award with issuance/memorandum/document showing the Criteria for the Search  Research and Innovation. Duly approved proposal; Accomplishment Report; Certification of Utilization by the local office; Certificate of Adoption by another office; Proof of Citation by other researchers  Subject Matter Expert. Memorandum showing membership in a National Technical Working Group (NTWG); Certificate of Participation/Attendance; Output/Adoption by the organization


