DIVISION MEMORANDUM No. 290 s. 2025

RE-COMPOSITION OF DIVISION REVIEW AND EVALUATION COMMITTEE FOR THE ESTABLISHMENT, MERGING, CONVERSION, AND NAMING/ RENAMING OF PUBLIC SCHOOLS, SEPARATION OF PUBLIC SCHOOL ANNEXES; AND IMPLEMENTATION OF SENIOR HIGH SCHOOL PROGRAM IN PUBLIC SCHOOLS

- DepEd Order No. 40, s. 2014 defines the policy guidelines on the establishment, merging, conversion, and naming/renaming of public schools, and separation of public school annexes in basic education. This aims to streamline and synchronize the work processes to be undertaken.
- 2. Likewise, DO 51, s. 2015 provides guidelines on the implementation of the senior high school (SHS) program in existing public junior high schools (JHSs) and Integrated Schools (ISs), establishment of stand-alone public SHSs, and conversion of existing public elementary and JHS into stand-alone SHSs. These guidelines include the systems and procedures, as well as standards and criteria in the implementation of SHS in public schools regardless of Track and Strand offering.
- 3. For the purpose of streamlining a committee membership in carrying out the intents of the aforfementioned issuances, there shall only be one Division Review and Evaluation Committee (DREC). Hence, the following shall compose the DREC with the School Management Monitoring and Evaluation (SMME) and Legal Officer as additional members, to wit:
