**DISSEMINATION AND COMPLIANCE WITH REGIONAL MEMORANDUM NO.658,  
S. 2025 – CONTINUANCE OF THE IMPLEMENTATION OF THE CLASSROOM-  
BASED SESSION AGAINST ONLINE SEXUAL ABUSE OR EXPLOITATION OF  
CHILDREN (OSAEC) AND CHILD SEXUAL ABUSE OR EXPLOITATION  
MATERIALS (CSAEM)**

1. In reference to Regional Memorandum No. 658, s. 2025, and its attached issuances (RM No. 158, s. 2025 and OM-OUOPS-2025-11-03707), this Office enjoins all public elementary and secondary schools in the Division of Tabuk City to continue the implementation of the classroom-based sessions against Online Sexual Abuse or Exploitation of Children (OSAEC) and Child Sexual Abuse or Exploitation Materials (CSAEM).

2. These sessions aim to raise awareness and equip learners with knowledge and tools to protect themselves from online sexual abuse and exploitation. The program is aligned with the Department of Education's 5-Point Reform Agenda, particularly in promoting learner well-being and ensuring a safe learning environment.

3. The following guidelines shall be observed:

A. Implementation:

All schools shall conduct the classroom-based sessions for each key stage. These shall be delivered by class advisers during the Homeroom subject on any day until **October 24, 2025**.
