Dissemination of RM 589, s. 2025-Downloading of the FY 2025 Special Needs Education (SNED) Program Support Fund (PSF)

1. Pursuant to RM 589, s. 2025 entitled "**Downloading of the Fiscal Year (FY) 2024 Special Needs Education Program Support Fund**" dated August 12, 2025, this office informs the recipient schools on the downloading of the FY 2025 SNED PSF to schools with Learners with Disabilities (LWDs), amounting to P530,000.00.
