



## CONTRACT FOR PROCUREMENT OF MEALS AND SNACKS FOR HUMAN RESOURCE TRAINING AND DEVELOPMENT(HRTD) FUNDED ACTIVITIES

This **CONTRACT** executed on the 15th day of February 2024 by and between:

**Department of Education-Schools Division of Tabuk City**, a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

**Kingsquare Davidson Hotel and Restaurant Corporation** a company duly organized and existing under the laws of Tabuk City, Kalinga, Philippines, with principal office at Purok Datu, Bulanao, Tabuk City, Kalinga, hereinafter called "the Supplier".

**WHEREAS**, the Entity invited Bids for certain goods and services/works/consulting services, particularly **Procurement of Meals and Snacks for Human Resource Training and Development(HRTD) Funded Activities**;

**WHEREAS**, the Supplier/Contractor/Consultant submitted a responsive bid and was awarded the contract for the procurement in the total amount of **Two Million Six Hundred Eighty Thousand Eight Hundred Pesos Only (P2,680,800.00)**, hereinafter referred to as the "Contract Price."

**NOW, THEREFORE**, for and in consideration of the foregoing premises, the parties hereby agree as follows:

- 1) Unless otherwise stated, terms and expressions used in this Contract shall have the same meanings as those assigned to them in the Conditions of Contract, which form an integral part of this Contract.
- 2) The following documents as required by the Implementing Rules and Regulations of Republic Act No. 12009 shall form part and be read and construed as integral parts of this Contract, *viz.:*
  - a) Philippine Bidding Document (PBD);
    - **For Procurement of Goods**
      - i) Invitation to Bid;
      - ii) Instruction to Bidders;
      - iii) Bid Form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
      - iv) Bid Data Sheet;
      - v) Schedule of Requirements;
      - vi) Technical Specifications;
      - vii) General and Special Conditions of Contract;
      - viii) Supplemental Bid Bulletins, if any; and
      - ix) Other contract documents that may be required by existing laws and/or the Entity.

b) Winning bidder's bid, including the Eligibility Requirements, Technical and Financial Proposals, and all other documents or statements submitted;

c) Performance Security;

d) Notice of Award of Contract; and the Bidder's Conforme thereto; and

e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.

3) In consideration of the Contract Price of **Two Million Six Hundred Eighty Thousand Eight Hundred Pesos Only (P2,680,800.00)**, or such other sums as may be determined in accordance with the terms of the Contract, the Supplier/Contractor/Consultant agrees to deliver and perform the items and related services for the **Procurement of Meals and Snacks for Human Resource Training and Development(HRTD) Funded Activities** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4) The procurement covered by this Contract consists of the provision of Meals and Snacks (AM and PM) for Various Human Resource Training and Development (HRTD) Funded Activities of the Department of Education – Schools Division of Tabuk City.

The detailed breakdown of the awarded activities, including their respective descriptions and approved contract amounts, is hereby enumerated below and shall form an **integral part of this Contract as Schedule "A"**. Payment shall be made only for activities actually conducted and duly supported by the required reports, certifications, and acceptance documents.

5) Implementation of this Contract shall be **on a per-activity basis**, as enumerated in **Schedule "A"** hereof. The Department of Education – Schools Division of Tabuk City may implement **one or more activities**, subject to the availability of funds, approved training schedules, and actual conduct of the activity.

Payment to the Supplier shall be made **only for activities actually conducted**, delivered, and **duly accepted** by the Entity, and shall be based on the **corresponding approved amount per activity** indicated in Schedule "A".

No payment shall be made for activities **not implemented, postponed, or cancelled**, and such non-implementation shall not give rise to any claim for damages, lost profits, or additional compensation on the part of the Supplier.

Partial payments corresponding to completed and accepted activities may be processed, subject to the submission of complete supporting documents and compliance with applicable accounting, auditing, and government regulations.

6) The **Department of Education-Schools Division of Tabuk City** agrees to pay the above-mentioned sum to the Supplier/Contractor/Consultant in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

7) Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of 2004) or Executive Order No 1008, series 1985 (Construction Industry Arbitration Law).




