 LEARNING TOOLS AND EQUIPMENT-SCIENCE AND MATHEMATICS
 EQUIPMENT(LTE-SME) FOR PUBLIC SCHOOLS IN THE SCHOOLS
 DIVISION OF TABUK CITY**

This **CONTRACT** executed on the 26th day of February 2026 by and between:

Department of Education-Schools Division of Tabuk City, a government agency of the Republic of the Philippines, hereinafter called "the Entity";

-and-

J and G General Merchandise a company duly organized and existing under the laws of Tabuk City, Kalinga, Philippines, with principal office at Purok Datu, Bulanao, Tabuk City, Kalinga, hereinafter called "the Supplier".

WHEREAS, the Entity invited Bids for certain goods and services/works/consulting services, particularly **Early Procurement Activity(EPA) of Learning Tools and Equipment-Science and Mathematics Equipment(LTE-SME) for Public Schools in the Schools Division of Tabuk City;**

WHEREAS, the Supplier/Contractor/Consultant submitted a responsive bid and was awarded the contract for the procurement in the total amount of **Three Million Six Hundred Forty-Four Thousand Fifty-Seven Pesos and Seventy-Five Centavos Only (3,644,057.75)**, hereinafter referred to as the "Contract Price."

NOW, THEREFORE, for and in consideration of the foregoing premises, the parties hereby agree as follows:

d) Notice of Award of Contract; and the Bidder's Conforme thereto; and

e) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBD, such as but not limited to the Notice to Proceed and Warranty Security.

3) In consideration of the Contract Price of **Three Million Six Hundred Forty-Four Thousand Fifty-Seven Pesos and Seventy-Five Centavos Only (3,644,057.75)**, or such other sums as may be determined in accordance with the terms of the Contract, the Supplier/Contractor/Consultant agrees to deliver and perform the items and related services for the **Early Procurement Activity(EPA) of Learning Tools and Equipment-Science and Mathematics Equipment(LTE-SME) for Public Schools in the Schools Division of Tabuk City** described herein in accordance with the terms and conditions specified in the Contract and its annexed documents.

4) The **Department of Education-Schools Division of Tabuk City** agrees to pay the above-mentioned sum to the Supplier/Contractor/Consultant in accordance with the schedule and manner provided in the Bidding Documents and its annexes.

5) Any dispute, difference, or claim arising out of or relating to this Contract, including its existence, validity, interpretation, breach, or termination thereof, may be submitted to arbitration or other form of alternative dispute resolution in accordance with the applicable law, such as Republic Act No. 9285 (Alternative Dispute Resolution Act of


