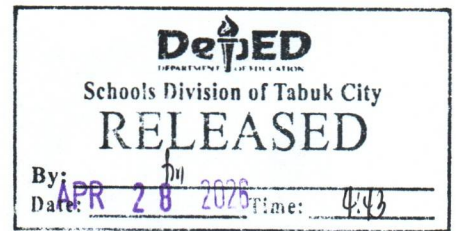

This Division Memorandum is issued to disseminate Regional Memorandum No. 295, s. 2026, relative to DM-OUHRODI-2026-1125, titled “Dissemination of Questionnaire on School Forms and Gathering of Inputs from Teachers,” together with the related advisory issued by the Bureau of Human Resource and Organizational Development (BHROD).

5. School Heads are hereby directed to ensure wide dissemination of the questionnaire within their respective schools and to encourage voluntary participation among teachers and school personnel.
