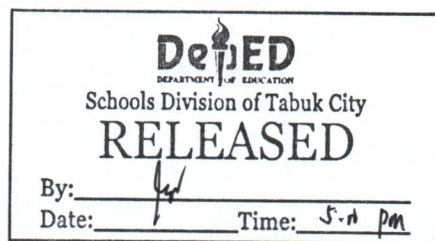

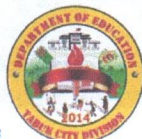

**DEPARTMENT OF EDUCATION LED SCHOOL-BASED FEEDING PROGRAM
(SBFP) IMPLEMENTATION FOR SCHOOL YEAR 2026-2027**

1. Pursuant to Republic Act No. 11037, "Masustansyang Pagkain para sa Batang Pilipino Act," enacted on June 20, 2018, which is also known as the National Feeding Program; and in accordance to DepEd Order No. 013, s. 2026, "Institutional Guidelines on the Implementation of the School-Based Feeding Program", this office through the School Health and Nutrition Unit, School Governance Operation Division (SGOD), will implement the School-Based Feeding Program (SBFP) Hotmeals starting on July 6, 2026 covering 89 feeding days.
2. This program aims to address undernutrition and hunger among Kindergarten to Grade 6 learners and Pregnant adolescent learners from Junior and Senior High School, specifically those classified as severely wasted, wasted, stunted, severely stunted, or at risk of dropping out.
3. The number of beneficiaries per classification per school is contained in Enclosure No.1 as identified from the recently concluded Baseline Nutritional Status Assessment of all learners in SDO Tabuk City. While the Cycle Menu Plan for SY 2026-27 can be identified at Enclosure No. 2. Hot meals will be prepared by the following school kitchens or canteens following the Monday to Friday timeline.
4. School Heads, SBFP Technical Working Group members, Division School Health and Nutrition Unit personnel, School Feeding Coordinators, and other relevant staff are tasked to lead and monitor the program's implementation at the school level.
