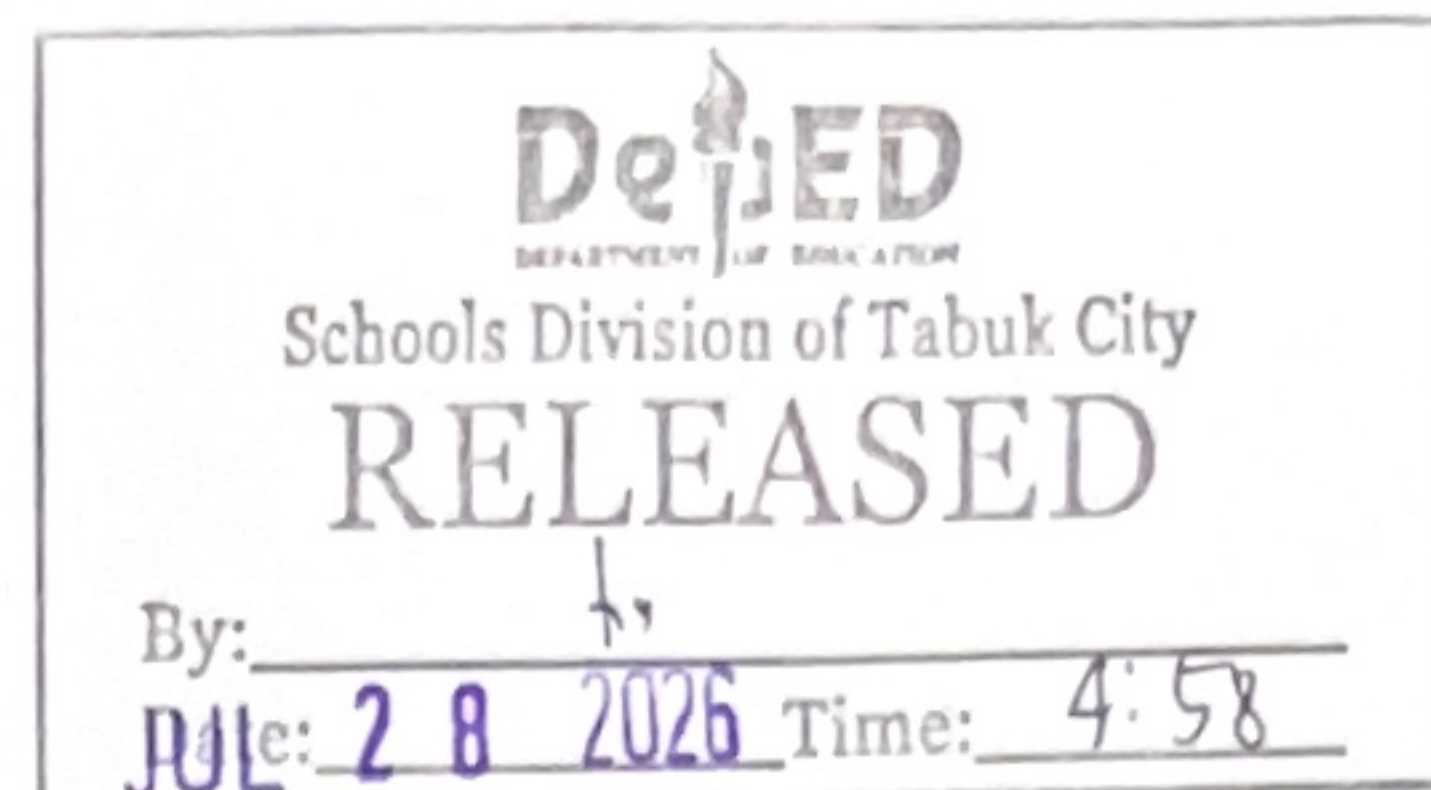

**MONITORING ACTIVITIES AND SCHOOL VISITS DURING THE
INSTRUCTIONAL BLOCK FOR SY 2026-2027**

1. In reference to DM-OULS-2026-320 dated 24 July 2026 issued by the Office of the Undersecretary for Learning Systems, all concerned are hereby informed that monitoring activities and school visits shall continue to support the effective implementation of the Instructional Block for School Year 2026-2027 on July 27 to August 7, 2026.

2. The monitoring activities aim to:

- a. Assess school readiness and instructional delivery;
- b. Monitor compliance with Learning Systems policies, including the three-term school calendar;
- c. Identify implementation issues, concerns, and emerging good practices;
- d. Gather stakeholder feedback; and
- e. Provide immediate technical assistance to schools, as necessary.

3. All school heads are directed to:

- a. Extend full cooperation to authorized monitoring teams;
- b. Prepare relevant documents and data needed during the visit;
- c. Ensure that monitoring activities are conducted efficiently and without disrupting regular classroom instruction and other school operations; and
- d. Facilitate the provision of technical and logistical support, as appropriate.

4. Public Schools District Supervisors and Education Program Supervisors shall coordinate with schools within their respective areas to ensure the smooth conduct of monitoring activities and the immediate resolution of issues requiring technical assistance.
