1. In line with the celebration of the **126th Philippine Civil Service Anniversary (PCSA)** through **GANDANG HR: The Kalinga Public Service Convergence – Lumin-awa Kalinga**, the **Schools Division of Tabuk City** shall participate in the **2026 Inter-Agency Sports Fest** to be conducted throughout the **whole month of September 2026**. The activity forms part of the month-long celebration and aims to promote **employee wellness, camaraderie, teamwork, sportsmanship, and stronger convergence among public servants**.

2. The activity is in keeping with the continuing efforts of the Department of Education to promote the physical, mental, and social well-being of its personnel. Participation in sports activities provides an avenue for employees to maintain physical fitness, develop teamwork and discipline, strengthen interpersonal relationships, and foster a positive and healthy workplace environment.

3. In this connection, the duly identified and endorsed personnel of the Schools Division Office of Tabuk City and its schools are hereby authorized to represent DepEd Tabuk City in the Basketball Men's Team and Volleyball Women's Team and to participate in the scheduled team practices, official games, and other related activities for the duration of the 2026 Inter-Agency Sports Fest.

All participating personnel are expected to properly coordinate with and inform their immediate supervisors and/or school heads regarding their participation in scheduled practices and official games. The concerned supervisors and school heads are likewise encouraged to extend reasonable support and appropriate consideration to participating personnel, subject to the exigencies of the service and the need to maintain the efficient delivery of DepEd programs and services.

In cases where the schedule of an official game or authorized team activity coincides with regular office or school hours, the concerned personnel may be allowed reasonable time to participate, subject to proper coordination, appropriate work arrangements, and the approval of the concerned immediate supervisor or school head. Such arrangements shall take into consideration the exigencies of the service and shall ensure that essential functions, and public services are not adversely affected.
6. The participation of the identified employee-athletes shall form part of the official representation of the Schools Division of Tabuk City in the 2026 Inter-Agency Sports Fest. Accordingly, the cooperation and support of all concerned offices, schools, supervisors, and personnel are highly encouraged to enable the participating teams to adequately prepare for and participate in their scheduled games.
7. All participating personnel are expected to observe proper conduct, sportsmanship, discipline, teamwork, and professionalism throughout the duration of the activity. They shall likewise comply with the rules and regulations prescribed by the organizers and observe applicable DepEd policies and standards of conduct.
8. The official list of the Overall Team Managers, Basketball Men's Team Members and Coaching Staff, and Volleyball Women's Team Members and Coaching Staff is attached to this Memorandum and shall form an integral part hereof for the information, reference, and appropriate action of all concerned.
9. Uniforms, personal sports equipment, and other incidental expenses related to participation in the activity shall be shouldered by the participating personnel, unless otherwise provided through authorized and available funds or legitimate sources of support.
10. The concerned personnel shall ensure that their participation in the activity is properly coordinated with their respective offices and schools and that any necessary arrangements for the continuity of their regular duties are made prior to their attendance in practices and official games.
