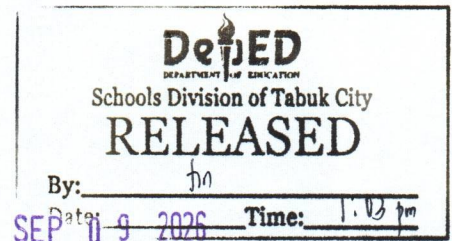

2. The activity is organized by the Alliance of Concerned Teachers (ACT) and is intended to provide an avenue for teachers and education workers to discuss organizational and sectoral concerns.
3. Participation in the activity shall be strictly voluntary. No teaching or non-teaching personnel shall be required, compelled, or unduly influenced to attend or participate in the said activity.
4. Personnel who voluntarily participate are reminded to observe applicable laws, rules, and regulations and to ensure that such participation does not prejudice the performance of any official duty or responsibility.
5. School heads and immediate supervisors are advised to exercise appropriate administrative discretion in addressing matters concerning personnel participation, consistent with existing DepEd policies and the exigencies of the service.
6. The use of the Schools Division Office premises as venue shall be subject to the approval of the Schools Division Superintendent and compliance with applicable government rules and regulations on the use of government facilities.
7. This Advisory is issued solely for information and appropriate guidance. It shall not be construed as an institutional endorsement, sponsorship, or adoption by the Schools Division of Tabuk City of any organizational position, advocacy, or activity of ACT.
8. All school heads and Division Office unit heads are directed to disseminate this Advisory to all concerned personnel for their information and guidance.
